If you fail to appear in court as required by law on or before you appear date, you may be denied the renewal of your Driver's License and assessed an additional fee.

JUVENILES (PERSONS UNDER THE AGE OF 17), Must contact the Court and schedule an appointment to appear in person with a Parent/Guardian in front of the Judge.

NOTICE OF DEFENDANT'S RIGHTS

You have the right to;

Enter a <u>Plea of Not Guilty</u> and request a trial by Judge or a Trial by Jury. OR Enter a plea of <u>Nolo Contendre or Guilty</u> and waive trial by jury

OPTIONS TO TAKE CARE OF CITATION:

- Request a Payment Plan
- Request Community Service
- Request Time Served (only if you have been in Nacogdoches jail)
- Request an Indigency Hearing. You must provide facts & evidence to the court.
- Request DSC Driver's Safety Course before appearance date
 - \$146.00 is due at the time of DSC request
 - Defendant is responsible for:
 - Copy of Driver's license
 - Insurance card
 - Search for a Texas State Approved course to complete
 - Order a driving record.

(You will have 90 days from appearance date to complete.)

- Request Deferred Disposition
- Pay the fine in full

You may do this by mailing a cashier's check or money order made payable to Nacogdoches County once you have pled (see plea form below). Please include case number and/or Name of Defendant. Please be certain these types of payment are complete before mailing.

Types of Payment accepted:

- Exact cash, money order or cashier's check only in office
- Online payments can be made at <u>www.govrec.com</u>
- The convenience fee is \$5.00 per \$100 a transaction.
