**PENALTY FOR MAKING OR USING FALSE AFFIDAVIT-a person who makes or uses an affidavit knowing to be false, shall be fined as provided in Title 18 United State Code, or imprisoned for not more than one year or both.**

**Only if the Affidavit establishes that the Defendant is not an active service-member can the Court proceed with a Default Judgment in the normal fashion.**

2. You will have to agree to US Government Agreement.
3. Select: Single Record Request
4. Create An Account: Type in Username and Password. Security Check: NEXT. Security Questions. Terms of Agreement. ✓ Accept. Submit.
5. You will receive an email for verification.
6. Type in Defendant's date of birth and last name. Accept the Agreement.
7. Click Submit and print out the military status and turn in with the petition.

**\*\*Keep in mind, you will only have to provide proof of the Military Status if Defendant does not appear in Court\*\***
